## SECTION – I

### INSTRUCTIONS TO THE TENDERERS

#### 1. Definition

Unless the context otherwise requires, the following terms shall have the meanings assigned to them:

- **“MSSCL”** means *Maharashtra State Seeds Corporation Limited, Akola.*
- **“Supplier / Contractor”** means the person, firm, or company to whom the order for supplying manpower and equipment is issued, and shall include their authorized representatives, successors, heirs, executors, and administrators, unless otherwise provided in the contract.

#### 2. Eligibility

Only reputed, established, and registered contractors/companies are eligible to participate, subject to the following conditions:

- Must possess a valid **License for engaging skilled, semi-skilled, and unskilled workers** from the Assistant Labour Commissioner. *(If not available at the time of tender, it must be submitted within 15 days of issuance of the work allotment order.)*
- Must have a **minimum annual turnover of ₹3,00,000.**
- Must possess **Provident Fund registration** and other statutory registrations.
- Must submit all documents listed in the *Technical Bid (Annexure–A)*.
- Subletting, assigning, or transferring the contract in full or part is strictly prohibited without prior written permission of MSSCL.

## 6. Submission Requirements

- All required information and documents must be submitted.
- Incomplete tenders will be rejected.
- Extra sheets may be attached wherever necessary.

## 7. Alterations & Corrections

- Erasures or overwriting should be avoided.
- Any correction or modification must be **signed and stamped** by the authorized signatory; otherwise, the tender may be treated as invalid.

## 8. Rejection of Tender

A tender shall be rejected in the following cases:

- a) Failure to meet the requirements of the Technical Bid.
- b) Conditional Tenders.
- c) Tenderers not meeting MSSCL's evaluation criteria.

**9. When two or more bidders quote the same lowest rate in a government/semi-government tender, the Tie is resolved in this order:**

**1. Technical & Financial Evaluation**

- Committee checks overall technical strength and financial capability.
- The bidder with better technical-financial score may be selected as L1.

**2. Experience & Capacity Check**

If rates are equal, the department compares:

- Preference will be given past performance with MSSCL / similar work
- Ability to execute work (capacity, manpower, resources will be evaluated)
- Financial stability (higher turnover will be preferred)
- Penalties or issues in previous contracts  
The most capable bidder is preferred.

**3. State/Local Preference (if applicable)**

- Preference may be given to eligible local or state suppliers as per rules.

**4. Revised/Improved Offer**

- All tie bidders may be asked to submit a sealed lower revised rate.
- The lowest revised offer becomes L1.

**5. Draw of Lots (Final Method)**

- If all above steps fail, a sealed draw of lots is conducted
- In presence of the procurement committee and all bidders
- The name drawn is declared L1.

**6. Final Decision**

- The procurement committee's decision, recorded as per rules, is final.

## 10. Site Visit

A committee may visit the tenderer's premises or clients' locations for verification after opening the Technical Bids, if deemed necessary.

## 11. Re-Tendering Conditions

Re-tendering may occur in the following situations:

- a) Fewer than two technically eligible bidders remain after evaluation.  
*However, MSSCL may consider a single eligible tender if urgent requirements exist.*
- b) Lowest rate received is not acceptable to MSSCL.
- c) Extension may be granted depending on the number of tenders received.

## 12. Quotation of Prices

- MSSCL considers the **current agricultural minimum wages** for labour as the base rate.
- Tenderers shall quote **Service Charges (as percentage only)** over the total daily wage per labour.
- Wages are presently **₹449.38/day per labour** (as per Table "A").
- Service charge must be **more than 1%**.  
(Rates  $\leq 1\%$  shall be rejected.)
- Taxes shall be **excluded** from the service charge rate.
- If the Government revises wages, the updated rates shall be applicable.

### **13. Location of Work**

All manpower shall be provided at the following locations :

**Field Test & Field Emergence Test Farm, MSSCL Research & Development Unit, Pailpada, Akola.**

### **14. Printed Conditions of Tenderer**

Any printed terms & conditions submitted by the tenderer shall be ignored unless specifically accepted in writing by MSSCL.

### **15. Earnest Money Deposit (EMD)**

- Tenders must be submitted physically in *two sealed envelopes*.
- Tender Fee is **non-refundable**.

### **16. Price Revision**

No request for price enhancement will be entertained after opening the tender.

### **17. Submission Format**

All offers must be submitted in the prescribed format only.

Tenderers or their authorized representatives may remain present.  
No modification in the bid shall be permitted during opening.

### **19. Validity of Offer**

The offer shall remain valid for **90 days** from the date of opening of the Price Bid.

If the due date for validity falls on a holiday, the next working day shall apply.

### **20. Discretion of MSSCL**

MSSCL reserves absolute rights to:

- Accept or reject any or all tenders,
- Cancel the tender,
- Increase or decrease the number of labourers required.

Labour requirement may vary depending on sample loads and seasonal activities.

## **21. Refund of EMD**

### **For Unsuccessful Tenderers:**

EMD will be refunded without interest after finalization.

### **For Successful Tenderers:**

- Refund after execution of contract and deposit of Security Deposit.
- EMD may be adjusted against Security Deposit on request.
- No interest shall be paid.

Successful tenderers must also execute an agreement on **Non-Judicial Stamp Paper equivalent to 0.1% of contract value (minimum ₹500)**.

## **22. Forfeiture of EMD**

EMD shall be forfeited if the tenderer:

- a) Withdraws bid before final decision.
- b) Fails to execute the contract after acceptance.
- c) Fails to deposit the Security Deposit within 15 days of order.

## **23. Security Deposit & Agreement**

- Minimum **₹10,000** to be deposited within 15 days of award.
- MSSCL may demand higher security if required.
- Agreement must be executed on stamp paper of **0.1% of contract value (minimum ₹500)** within 15 days.

## **24. Authorization**

The person signing the tender must attach a valid authorization letter or Power of Attorney, as per company/firm by-laws.

## **RIGHT TO ACCEPT OR REJECT**

The **MSSCL, Akola** reserves the absolute right to accept or reject any or all tenders, or split the order among more than one contractor, without assigning any reason.

## **JURISDICTION**

All disputes shall fall under the jurisdiction of **Civil Courts in Akola only**.

## **SECTION II**

### **TERMS AND CONDITIONS OF THE CONTRACT**

1. The labourers deployed at the Field Test & Field Emergence Test Farm, R&D Unit, Pailpada shall compulsorily perform all day-to-day agricultural operations including sowing, thinning, weeding, transplanting, inter-cultural operations, application of fertilizers, spraying, protective irrigation, field observations, harvesting, threshing, security of standing crops, and any other related farm activities as instructed by MSSCL.
2. Based on experience, actual expenditure, and operational requirements, MSSCL reserves the right to extend the contract or execute a new contract with suitable modifications, if required.
3. All necessary agricultural inputs shall be provided by MSSCL.
4. The number of labour required may be increased or decreased depending on samples. The total tentative labour required are 705 upto December 2026. The expected Labour payment considering the present wages @ Rs.450/-labour per day .Total Tentative expected Labour Payment may be Rs.317250/- .The actual payment will be done only on actual labour engaged for MSSCL work.
5. The contractor shall mandatorily supply the required number of labourers on a daily basis for smooth execution of farm activities.
6. All farm activities performed by the labourers shall be monitored and supervised by MSSCL officers from time to time.
7. It shall be the contractor's obligation to provide labourers strictly as per MSSCL's requirements.
8. Monthly payments shall be released at approved contract rates through RTGS/NEFT after receiving monthly bills from the contractor. The contractor must submit, along with each monthly bill:
  - Labour-wise PF deposit slips (duly certified),
  - ESIC challan,
  - Proof of labour wage payment (bank slips/RTGS slips),
  - Duly certified proof of statutory deductions made from labour wages.
9. The contractor must pay wages to the labourers strictly as per prevailing Government norms.
10. The contractor must release labour wages directly into the respective labourers' bank accounts via RTGS on or before the 3rd of working

days of the month.

In case of delay, after a grace period of 15 days, a penalty of **1% per day** (calculated in intervals of 0.1%, 0.3% and 0.7%) shall be deducted from the contractor's bill or security deposit.

The contractor shall provide MSSCL with proof of wage payments for reimbursement purposes.

11. The contractor must have the capacity to supply a minimum of **25 labourers per day** for smooth functioning of farm activities.
12. If any crop damage occurs due to non-availability or short supply of labourers by the contractor, MSSCL shall complete the work through other sources, and the cost incurred shall be deducted from the contractor's bills.
13. Monitoring and supervision of the labourers' attendance, discipline, and performance shall be the sole responsibility of the contractor.
14. In the event of any accident or injury to labourers during work, the contractor shall be fully responsible for providing necessary care, support, and compensation as applicable under law.
15. If any labourer engaged by the contractor raises a complaint related to unfair labour practices, the contractor shall bear all costs, liabilities, and consequences arising from such complaints.
16. The contractor awarded the labour contract must execute a formal agreement with MSSCL for the period **01/01/2026 to 31/12/2027**.
17. If the contractor abandons or discontinues the contract before expiry of the contractual period, MSSCL shall recover all damages and forfeit the contractor's Security Deposit.
18. The contractor shall also provide labourers for housekeeping duties to maintain cleanliness of the premises of R&D Unit, Pailpada.
19. The contractor shall maintain all statutory records and documents of the labourers as per Government norms and shall produce them for inspection whenever required.
20. TDS shall be deducted from the contractor's payments as per applicable Government rules.
21. The Contractor shall provide all documents required by MSSCL finance department time to time & as per Govt norms .
22. Self-attested copies of Aadhaar Card and PAN Card of the contractor shall be submitted with the agreement.

23. Both parties expressly waive the provisions of Section 12(5) of the Arbitration & Conciliation Act, 1996 and agree to refer any dispute relating to the terms or performance of this contract to the Hon'ble Managing Director, MSSCL, who shall act as the **Sole Arbitrator**. The decision of the Sole Arbitrator shall be final and binding on both parties. The place of arbitration shall be MSSCL Head Office, Akola, and the language of arbitration shall be English.

24. Irrespective of the place of execution of this agreement, both parties mutually agree that the agreement shall be deemed to have been executed at Akola, Maharashtra, and only the **Courts at Akola** shall have jurisdiction to challenge the Arbitral Award.
